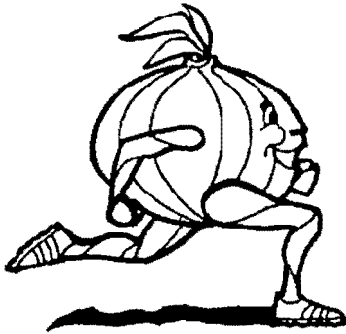


35th Annual Vidalia Onion Run

Saturday, April 28, 2012

- 7:30 am - 1 Mile Fun Run/Walk
- 8:00 am - 5K Onion Run/Walk & 10K Onion Run/Walk

All events begin and end on Church Street in Vidalia, Georgia, between First Baptist Church and First United Methodist Church

\$3,500 in prizes available to runners/walkers

- Cash prizes to top 3 schools with most participation
- 5 drawings for \$100 for runners/walkers
- Awards for top 3 female and male runners, overall, in 1 Mile Fun Run
- Awards for top 3 female and male runners in all age divisions in 5K Onion Run and 10K Run and awards for top 3 female and male runners, overall, in 5K Onion Run and 10K Onion Run
- \$1,500 to any female or male runner who wins the 10K Onion Run and who sets a new female or male course record for 10K Onion Run

Runners in 5k and 10k will receive race bib with assigned computer chip.

Race bibs with computer chips MUST be worn to ensure proper place of finish. Bibs are disposable after races.

Thereafter, race packets will be available in the parking lot of First Baptist Church in Vidalia, GA on April 28, at 6:30 am

*Participants who want to run in 1 Miles Fun Run and either 5K Onion Run or 10K Onion Run must register separately and pay separately for each.

*All registered participants will receive a commemorative race t-shirt. Fruit bar and fluids will be provided at finish line.
