

Atlanta Dogwood Festival's Mimosa 5K Run/Walk

Saturday, April 8, 2017 | Start Time: 8:00 am | (Registration begins at 7am)

The race is in honor of this year's 81st anniversary celebration. Although this is the 3rd oldest fine arts festival in the country it is only the 3rd year of the race. The delightful course through historic Midtown culminates in a champagne and orange juice - "Mimosa" celebration in the park directly after the race.

Race Location: Charles Allen Drive and 10th Street Entrance of Piedmont Park.

Route: The race begins on 10th Ave near the Charles Allen entrance of Piedmont Park, heads west to Piedmont Ave, turns right passing the Atlanta Driving Club and the Atlanta Botanical Gardens. It turns right onto Monroe Drive and continues to 10th Ave. There it turns right reconnecting to the Charles Allen Drive park entrance where it finally finishes in the park.

Awards: Overall Male & Female, Masters Male & Female, 3 deep in age groups in 5 year increments from 10 & under to 70 & over (ie 20-24, 25-29 etc.)

Proceeds: Benefit the Atlanta Dogwood Festival's free programming.

Entry Cost information: \$30 before March 3, 2017 . \$35 until April 7, 2017. Registration will be \$40 day of the race. If shirts run out, priority is given to prior entries. Later entries may have shirts mailed after the race.

Other Information: This is a qualifying race for the Peachtree Road Race. Race packet pick up will be at Phidippides Running Store in Ansley Mall, Sat. April 1 and April 3-5.
